- AISH / ADAP**
The mandatory transition of 79,300 Albertans with permanent disabilities to a lower-paying, employment-focused program on July 1, 2026, without individual reassessment and without independent appeal rights.
- FSCD / PDD**
The elimination of FSCD and PDD advocacy organization funding mid-contract in March 2026, during the exact period when families navigating complex disability systems need support the most.
- Homelessness and Housing**
The ongoing failure to address housing instability for Albertans with disabilities, fixed incomes, and complex needs, including cuts to supports that prevent homelessness.

Canada Disability Benefit Clawback

Alberta is the only province clawing back the federal Canada Disability Benefit dollar-for-dollar, redirecting federal poverty-reduction funding into provincial general revenue.

Appeal Rights Removed

Bill 12 (December 2025) removed the independent Citizens Appeal Panel, eliminating the only mechanism by which AISH recipients could challenge program decisions externally.

I am writing as an Albertan who is not a recipient of AISH but who objects to the policy decisions currently being made regarding Alberta's disability support framework.

I am submitting this letter in relation to the following concerns: [list the issues you checked in Section 2].

I believe that the treatment of Alberta's most vulnerable residents is a matter of public accountability that belongs to all Albertans, not only those directly affected. The mandatory AISH-to-ADAP transition, the elimination of independent appeal rights through Bill 12, the clawback of the federal Canada Disability Benefit, and the mid-contract elimination of FSCD and PDD advocacy funding represent a pattern of policy decisions I cannot support in silence.

- Send to all recipients at once. Use BCC to protect the privacy of others if sending to multiple people.
- Screenshot your sent email. Keep the receipt as part of your own record.
- If you receive a response, note the date, the name of the respondent, and what was said.
- Weekly letters from the same person signal sustained concern, not a one-time complaint.
- Sharing this form multiplies the impact. Every submission adds to the documented record.
